PCR Board Resolution 2022-007:

How to be a PCR Member in Good Standing and get a Certificate of Good Standing (COG):

Whereas the New SEC approved and Amended PCR By Laws of 2012 Article 4 Membership, Article 4.4. Describes the duties and obligations of a member

Whereas, under Article 4.4.1 Members shall be considered in “good standing” if the following duties are fully satisfied:

Whereas, under Article 4.4.1.1 Fellows and Diplomates must maintain eligibility to practice medicine as well as maintain good standing status of any recognized Accredited Professional Organization of the Professional Regulation Commission; Whereas, under Article 4.4.1.2 All members are expected to strictly abide by the Approved Guidelines for the Practice of Radiology in the Philippines, Code of Ethics for Radiologists, Guidelines for Professional Fees of Radiologists, and Rules and Regulations of the Chapters where they practice.

Whereas, under Article 4.4.1.3 Fellows and Diplomates must undertake continuing medical education and accrue Continuing Medical Education (CME) units for re-validation or re-instatement of membership as determined and prescribed by the Board of Directors. Whereas, under Article Fellows Emeritus and Honorary Members are not required to pay the annual dues of the College.

Whereas, the PCR Board Resolution 2017-003, contains the requirements to be a PCR member in good standing and has been enumerated

Whereas, in addition, the Board Resolution 2018-022 states that a certificate of good standing from the respective PCR chapter, is a requirement to be issued a certificate of good standing from the PCR office

Whereas the New SEC approved and Amended PCR By Laws of 2012, ARTICLE 10 CHAPTERS 10.1.1 states that “All fellows and diplomates are required to be a member of one (1) recognized chapter. “

Whereas an online meeting of the Board of Trustees of the Philippine College of Radiology (PCR) on January 8, 2023, using the Zoom platform, a quorum was present.

Now, therefore, be it resolved that, pursuant to the PCR Bylaws, the Board of Trustees of the PCR hereby present the following modified set of criteria to be fulfilled by a PCR member to be in good standing and would thereby be issued a certificate of good standing:

Must be updated and must have paid all dues of the PCR

Must have NO unresolved issues with the PCR ethics committee

Must have attended two (2) out of three (3) consecutive PCR Business meetings (General Assembly)

Must present a valid Certificate of Good standing from respective PCR Chapter

Must have proof of attendance from the following PCR events, to earn a total of 50 points.

PCR Events =Points

a. PCR Annual Convention =40

b. PCR Chapter Annual Convention =15

c. Subspecialty Convention

i. CTMRISP =15

ii. USP =15

iii. PSVIR =15

iv. PROS Annual Convention =40

d. CME scientific meetings (including those held by subspecialty and chapters) =10

e. Post Graduate courses of PCR accredited hospitals =5

f. Webinars related to the Practice of Radiology other than those organized by PCR and its component societies, with accompanying certificate of attendance or letter of acknowledgement from organizers =1 point / webinar related to Radiology (10 points max only)
